Current Emissions Reporting

In 2024, waste emissions increased, this is due to increasing production volumes compared to 2023. The rest of the Scope 1, 2 and 3 categories did decrease compared to 2023.

The company vehicles emission data targeted users through a survey instead of calculating the scope 1 related emissions which resulted in better quality data.

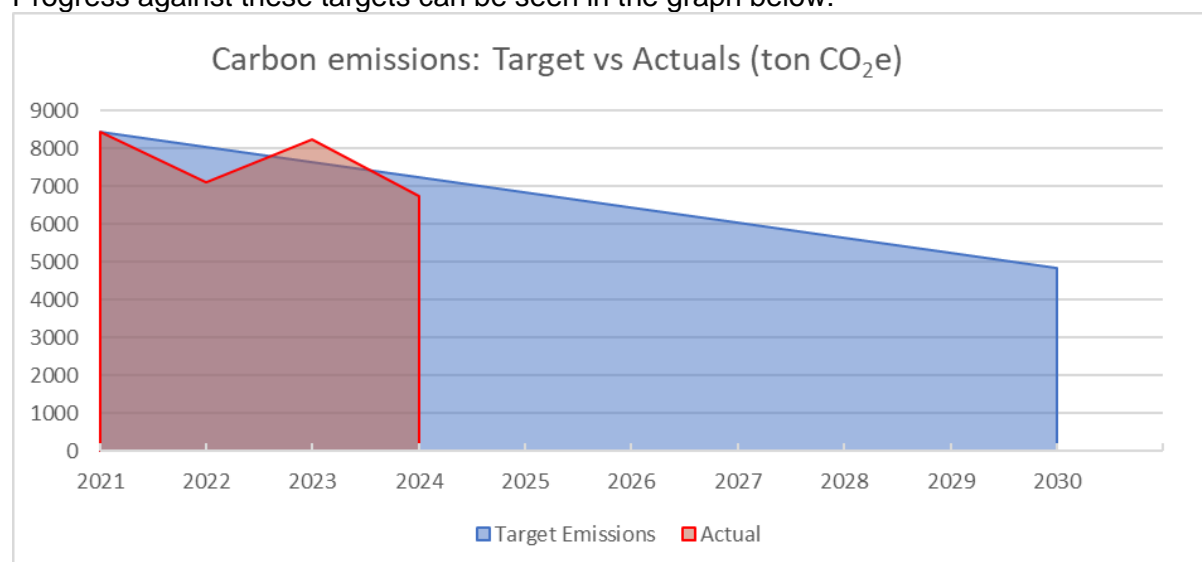

Emissions reduction targets

To continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets on a corporate level. Wellspect have set targets set and have been validated by Science Based Targets initiative (SBTi) since March 2024.

We project that carbon emissions (within the scopes and categories listed here) will decrease to **4857 tCO₂e** by **2030**. This is a reduction of **43%** compared with the base line year 2021. The targets were modified during 2023 as a result of the validation made by Science Based Targets initiative (SBTi).

Progress against these targets can be seen in the graph below:



Carbon Reduction Projects

Completed Carbon Reduction Initiatives during 2024:

- Share of air transports was reduced with 7% compared to 2023
- Introducing a 5% biofuel policy for the heating system at our distribution centre in UK reduced the use of natural gas by 5%.

- Completed 2024 sealing project of our sterilization equipment leading to reduced emissions and shall continue year on year.
- The above-mentioned activities have been completed and is the reason for the reduction seen in 2024.

The carbon emission reduction achieved by these schemes equate to 1511 tCO₂e, a 20% reduction against the 2021 baseline.

In the future we hope to implement further measures such as:

- Natural gas from fossil origin replaced by gas renewable sources.
- Implementing a new coating process at one of our manufacturing sites to aid reduction of our CO₂e.
- Ensuring further energy saving programs.
- Electrification of the full car fleet.
- Reduced air freight of products.
- Transportation with lower emissions.
- Reduction of hazardous waste.
